The bidding document in English language will be made available to eligible bidders on the submission of written application along with the copy of company / firm registration certificate and tax clearance certificate of fiscal year 2074/75 from the office upon payment of non-refundable fee of NRs 3,000 (Three Thousand Only) at Sanchit Kosh Khata No. 022000000004001071 in Nepal bank Limited, Baglung branch within office hour till 2075/11/22 (6th March 2019).
3. New bidders may apply in joint venture with an eligible firm having the required experience. If there are any discrepancies between this invitation for bid and the bidding documents always prevail.
4. Bid must be submitted to **Galkot Municipality, Baglung**, before 12:00 hour on 2075/11/23 (7th March 2019). If bidder wishes to submit the Bid security in the form of cash, bidder has to deposit cash in deposit (Dharauti Khata) account No 0220300000003000009 (Office code No:- 049-365-06) in the name of Galkot Municipality, Baglung in Nepal bank Limited, Baglung and submit bank deposit voucher along with the bid. Document received after this deadline shall not be accepted. Bids will be opened physically at 13:00 hour on 2075/11/23 (7th Feb 2019). A pre-bid meeting will be held on 2075/11/17 (29th Feb 2019) 14:00 hour at office of Galkot Municipality, Baglung. Bid validity /bid security periods shall be 90/120 days from bid opening dates respectively.
