Invitation for Bids for Following works

1. Galkot Municipality, Baglung invites bids for following works. Bids are open to all eligible Nepalese Bidders.
2. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Municipal Executive, Galkot Municipality or www.bolpatra.gov.np/egp.
3. Bidding documents may be purchased from the office of municipal executive, Galkot Municipality, Baglung or www.bolpatra.gov.np/egp by eligible bidders, on submission of a written application and upon payment of a non-refundable fee NRs, 3000.00 for bid documents as mentioned in the following table. The bidding document in English language will be made available to eligible bidders along with the copy of company / firm registration certificate and tax clearance certificate of fiscal year 2078/79. Bidders may submit their bid electronically download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders submitting their bid electronically, should deposit the cost of bidding document in the office internal revenue account as specified below and deposit voucher in Nepal Bank Limited, Baglung/Galkot, internal revenue Account No. 12303000001001000001 in the name of Galkot Municipality, Baglung.
4. New bidders may apply in joint venture with an eligible firm having the required experience. If there are any discrepancies between this invitation for bid and the bidding documents always prevail.
5. Bid must be submitted through www.bolpatra.gov.np on or before 12:00 noon on 2079/11/16 (28th Feb. 2023). Documents received after this deadline shall not be accepted.
6. Bids will be opened in the presence of Bidders' representatives who choose to attend at the meeting at 13:00 hours on 2079/11/16 (28th Feb. 2023) at the office of Municipal Executive, Galkot Municipality, Baglung. Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security, amounting according as mentioned in table below which shall be valid for 30 days beyond the bid validity period. In case of e-submission the bid security of pdf format should be attached through www.bolpatra.gov.np/egp. If bidder wishes to submit the Bid security in the form of cash, bidder has to deposit cash in deposit (Dharauti Khata) account No 12303000003000000001. in the name of Galkot Municipality, Baglung in Nepal bank Limited, Baglung/Galkot and submit bank deposit voucher along with the bid.
7. If the last date of pre-bid meeting, purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. Other terms and condition not covered here will be treated as clause of bid document and related procurement act and regulation.
